Tenders submitted on the official tender document that you have purchased are to be submitted in a sealed envelope, clearly marked **"TENDER NO. 01/2020-UEDA: SUPPLY AND ERECTION OF COLD ROOM FOR AGRI-HUB, UPGRADE OF ELECTRICITY FOR THE BUILDING AND SASILATION FOR ECONOMIC DEVELOPMENT AGENCY "** must be deposited in the tender box situated on the ground floor of the uThukela District Municipality, 36 Lyell Street, Ladysmith, on or before the closing time of **12h00 on Tuesday, 20 October 2020**, where the tenders will be opened in public. **Late quotations or Tenders received by way of Facsimile or E-Mail will under no circumstances be considered.**

1. The 80/20 Preference Points system will be applicable, with 80 points for price and 20 points for B-BBEE Status Level of Contribution.

All service providers intending to submit a tender are required to register for inclusion on the District's Service Provider Database. Forms are obtainable from the District's Supply Chain Management Office.

Tenderers shall take note of the following Tender Conditions:

- DDA's procurement policy will apply,
- DDA's does not bind itself to accept the lowest tender or any other tender and reserves the right to accept the whole or part of the tender,
- Tenders submitted are to be valid for a period of 90 days from the closing date for submissions of tenders.
- The Single Envelope System shall apply.
- A bidder must score a minimum of 60 points in respect of pre-qualification to be considered for evaluation/functionality.
- Only BBEE level 1 will apply.
- CIDB Grading 2GB.
