Tenderers should have a CIDB Contractor Grading as specified in the table above, or higher. Tenderer must score a minimum of 70 points for Functionality for the tender to be considered further.

A **Compulsory Site Inspection** will be held on **Wednesday 25 September at 11h00**. Failure to obtain a Tender Document or non-attendance at the site inspection will result in immediate disqualification of your tender, Tenderers are required to meet at the Ntabamhlope Site Office. The Ntabamhlope Site Office is located at the following co-ordinates 29° 07' 07.42"S ; 29° 41' 10.57"E.

Sealed tenders endorsed with the **Tender No. and Description of the Tender** must be deposited on the tender box of the uThukela District Municipality, 36 Lyell Street, Ladysmith before **12h00 on Friday 18 October 2019**, after which tender will be opened in public.

It is the Tenderer's responsibility to check the document on receipt for completeness and to notify the Employer of any discrepancies or omissions. It is the Tenderer's responsibility to provide all the data and information requested completely and, in the form, required, failure to do so may be regarded by the employer as a non-responsive tender.

A minimum of 15% of the value on the contract must be contracted to three (3) subcontractors who are:

- An EME or QSE
- EME or QSE which has at least 51% black owned
- EME or QSE which has at least 51% owned by black youth (from the ages 14 to 35)
- EME or QSE which has at least 51% owned by black people who are women
- EME or QSE which is at least 51% owned by black people with disabilities
- EME or QSE which is 51% owned by black people living in rural or underdeveloped areas or townships
- A co-operative which is at least 51% owned by black people
- EME or QSE which is at least 51% owned by black people who are military veterans; or more than one of the categories above.

uThukela District Municipality does not bind itself to accept the lowest or any of the tenders and reserves the right to accept the whole part or part of the tender.



Equitable Distribution of work and Awards

1. In an attempt to allow for greater exposure of emerging contractors within the precincts of the uThukela District Municipality, as well as to facilitate fair competition and service provider rotation, in instances where the Municipality advertises for the submission of bids, or issues a request for quotations for the supply and delivery of goods, or rendering of any service the Municipality reserves the right to award the contract or award to the candidate with the second highest points (referred to hereinafter for purposes of this section as "The Second Bidder") in instances where:
 - a. The recommended bidder has already been awarded a contract of the same or similar nature which still subsists at the date of Adjudication of the contract under consideration, and
 - b. The following criterion exist in respect of the following classes of contracts:
 - i. For construction related goods, services and / or infrastructure projects, the prices of The Second Bidder is market related and the difference between the final price of The Second Bidder and Recommended Bidder is not greater than 20% from the lowest quoted price which would have been awarded.
 - ii. For all other goods and/or services, the prices of The Second Bidder is market related and the difference between the final price of The Second Bidder and Recommended Bidder is not higher than 15% from the lowest quoted price which would have been awarded.
 - iii. For the purposes of this clause, the overall price of the submissions must be considered and not the prices on individual items or services submitted by the bidders.
