"TENDER NO. 06-2021-PPE: SUPPLY AND DELIVERY OF PROTECTIVE CLOTHING FOR UTHUKELA DISTRICT MUNICIPALITY" must be deposited in the tender box situated on the ground floor of the uThukela District Municipality, 36 Lyell Street, Ladysmith, on or before the closing time of **12h00 on Monday, 06 September 2021**, where the tenders will be opened in public. **Late quotations or Tenders received by way of Facsimile or E-Mail will under no circumstances be considered.**

All service providers intending to submit a tender are required to register for inclusion on the District's Service Provider Database. Forms are obtainable from the District's Supply Chain Management Office.

Tenderers shall take note of the following Tender Conditions:

- uThukela District Municipality's procurement policy will apply,
- uThukela District Municipality's does not bind itself to accept the lowest tender or any other tender and reserves the right to accept the whole or part of the tender,
- Tenders submitted are to be valid for a period of 90 days from the closing date for submissions of tenders.
- The Single Envelope System shall apply.
- 80/20 point system will apply
- Local production content will apply.
- The tenders will be required to meet the minimum threshold on Declaration Certificate for Local Production Content for Designated Sectors.

UThukela District Municipality will strive to achieve targeted procurement in accordance with Preferential Procurement Policy Framework Act Regulation 2017 in the manner that only bidders which have a BBBEE level 1 are targeted for this tender. The bidders which fail to meet the stipulated criteria will be regarded as non-responsive.
